

**MAASAI MARATHON SWEEPSTAKES
FOUR NIGHT STAY AT CAMPI YA KANZI IN KENYA**

OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. SWEEPSTAKES BEGINS AT 8 AM, Pacific Time ON October 12, 2009 AND ENDS AT 12:00 AM, Pacific Time ON October 31, 2009 (the “Sweepstakes Period”).

1. HOW TO ENTER: Go to www.maasaimarathon.com (the “Website”) and follow the on-screen instructions to make a donation of at least \$444.00 during the Sweepstakes Period and you will be automatically entered into the Drawing (defined below) for the Maasai Marathon Sweepstakes - Four Night Stay at Campi Ya Kanzi in Kenya. To enter without making a donation, please send an email to MaasaimarathonNYC@gmail.com between *9 AM Pacific Time on October 12, 2009 and no later than 12:00 AM Pacific Time on October 31, 2009* with the subject line “Maasai Marathon Sweepstakes - Four Night Stay at Campi Ya Kanzi in Kenya.. **ENTRIES MUST BE RECEIVED BY 12:00 AM Pacific Time on October 31, 2009.** No illegible, incomplete, forged or altered entries will be accepted. All entries become the exclusive property of Sponsor and will not be returned.

2. SELECTION OF WINNERS: Winners will be determined from all eligible entries received in one random drawing (a “Drawing”.) One Drawing will be held on or before November 5, 2009. The Drawing will be conducted by representatives of Sponsor whose decisions are final on all matters relating to this Sweepstakes. Winners will be notified by email at the email address provided upon entry on or about one (1) day after the date of the Drawing.

3. PRIZES AND ODDS: A four night stay at Campi Ya Kanzi in Kenya (<http://www.maasai.com/>) in a thatched roof cottage. The prize includes a safari while staying at Campi Ya Kanzi and all food during the winner’s stay. The prize does not include any transportation to and from Kenya or to and from the destination arrival in Kenya to the Campi Ya Kanzi. The winner is responsible for all other expenses. **TOTAL ARV OF ALL PRIZES:** \$4,000 US. Odds of winning depend upon the number of eligible entries received.
